Section 1 - General Competition Rules

	1. Overview
1.1	Competitions shall be organised and run as set out in these general rules and the specific rules and entry
	forms for each competition.
1.2	All play shall be in accordance with the Rules of Golf as laid down by the Royal and Ancient Golf Club of St
	Andrews, the Local Rules of the Club at which a competition is being played and any additional local rules or
	variations as stipulated by the NAPGC or its Competition Organisers.
1.3.	All competitors in events organised by the Association must be amateur in status and hold a valid WHS
	handicap index.
	2. The Committee
2.1	At all NAPGC Competitions there shall be a "Competition Committee", comprising NAPGC Board Members
	and duly appointed Committee Officials.
2.2	The term "Competition Organiser" used here in, or in the Rules and Conditions of any specific competition,
	relates to a person duly appointed by the NAPGC Board or Competitions Committee to organise that event.
2.3	The NAPGC is duly authorised to run competitions in accordance with WHS and all stroke play competitions
	where players return individual scores shall be counting for handicap purposes.
2.4	Any cases of dispute shall be referred to the Competition Organiser as soon as possible (this is important as
	any subsequent action by the Committee is dependent on the nature of the incident, timelines of reporting
	and whether the result has been announced).
2.5	In respect of any rule which requires the Committee in charge of the competition to act, a quorum shall be
	three and their decision will be final and binding on all parties.
	3. Entry to Competitions and Fees
3.1	Duly completed competition entry forms and fees should be submitted as directed on the website, by
	communications, or as set out in the entry form. This to be done before the published closing date.
3.2	Entry closing dates and entry fees shall be set by the Board of the Association or its Competition Committee
	and included on entry forms. All fees due must be received before the draw sheet issue date to confirm entry,
	otherwise club teams/players will be excluded.
3.3	Team and/or individual entries will not be accepted as received until any entry fee or playing fee due has been
	paid as set out in the entry form and through other communications.
3.4	There will be no refunds of team or individual entry fees after the entry closing date.

3.5	There will be no refunds of any playing fees after a start sheet has been issued.
3.6	Where events are over-subscribed, subject to availability and where appropriate, players or teams will be
	offered places at alternative venues.
3.7	A player must be a member of the Club they are representing and have their permission to enter or their entry
	will be void. Any entries inadvertently accepted will subsequently be voided and any team withdrawn and/or
	scores cancelled.
3.8	The Competition Committee reserves the right to alter or amend the conditions or dates of any competition or
	to reject any entry.
3.9	The NAPGC will endeavour to cover or subsidise green fees at national finals.
	4. Player Requirements
4.1	There is no upper or lower age limit for players, unless stated in the rules of a competition.
4.2	The word "Junior" shall refer to players who are aged Under 18 on the day of play. Junior players must produce
	completed parental consent forms when playing in any NAPGC Competition and be accompanied at the
	event by an adult who shall be responsible for them.
4.3	Within a competition year a player may not represent more than one club in team competitions or play for
	more than one team within a competition.
4.4	In all competitions, if it is subsequently discovered that a player has returned a score through playing off a
	handicap index higher than their entitlement, they and any team they are representing shall be liable to
	disqualification.
	5. Regional events and National Finals
5.1	For all competitions run by NAPGC officials, club officials, team captains or their representative players must
	provide in advance, player names, WHS/CDH numbers and other information as requested to the
	competition organiser in advance. The competition organiser will then verify against the WHS system.
5.2	On the day of any competition run by NAPGC officials, when booking in, team captains or players should
	confirm any changes to WHS handicap indexes.
5.3	If recent scores are not reflected on a player's WHS record, this must be reported to the Committee prior to
	play. Based on information provided an adjustment to handicap index will be considered in line with WHS
	guidance.
5.4	All score cards must be properly completed, signed off and promptly returned after play. At NAPGC organised
	events they shall be returned to the card return box or as otherwise directed by the Committee.
5.5	Local rules shall be advised to all players at NAPGC hosted events before play commences. They shall be
	reflective of the England Golf Hard Card and other specific course issues as required.
5.6	At NAPGC team finals, each team shall be permitted to appoint one person who may give advice to members
	of that team - in accordance with the Rules of Golf 24-4. The person shall be made known to the competition
	organiser in advance.
5.7	Spectators and supporters must not offer advice to players. At regional and national finals, they must not
	interfere with play or cause any group playing in the competition to be unduly delayed. They should where
	possible avoid walking along fairways and observe play from the side of holes only.
5.8	Any competitor, who during the course of a competition event, including between rounds, misbehaves by for
	example, swearing, throwing clubs, or vandalising the golf course or club house, or acts in any manner which
	might bring the name or the NAPGC into disrepute may be debarred from entering or taking part in any NAPGC
	competition for such period as the Competitions Committee may decide.
5.9	The competition committee shall direct which tees shall be used at NAPGC managed events.
0.1	6. Withdrawn Entries and No Shows
6.1	If any competitor (individual or team) withdraws from an event after the draw has been published, fails to
	appear on the tee at or within five minutes of their appointed starting time, or having qualified to continue in
	an event fails to do so, must furnish to the NAPGC Competitions Committee an explanation, in writing, to the
	satisfaction of the Committee. If they do not do so they will be debarred from entering or taking part in any
	NAPGC event for such period as the Competitions Committee may decide. In such circumstances, the player
	(or a club in a team competition) will be required to reimburse the NAPGC for any monies the organisation has paid by way of green fee subsidy.
	7. Equipment
7.1	Golf Balls: The ball the player uses shall be named on the current list of conforming golf balls issued by the
''	Royal and Ancient Golf Club of St Andrews.

7.2 Mobile Phones: While mobile phones (including pagers and similar devices) may be used as distance measuring devices, they should not be accessed on the course by players or caddies for making, sending or receiving calls or texts, except in cases of emergency. 7.3 <u>Caddies:</u> In all competitions except Junior events, players may use a caddie as defined in the Rules of Golf. 7.4 Buggies: The use of an on-course buggy if available or their own personal buggy is permitted in all NAPGC competitions unless precluded from doing so following a decision of the Course Management Authority. 8. Adverse Weather 8.1 Bad weather alone is not enough reason for not playing a match and in general, if a course is open as agreed by the CMA, then play in any competition should commence as arranged. However, if a course is otherwise considered unplayable in line with the rules of golf, the competition organising committee shall make a ruling on delay, suspension, abandonment or reduction in holes to be played. 8.2 At individual championship events, if after starting it is not possible for all players to complete their stipulated round, and following suspension it is not possible to resume and finish, then that round shall be abandoned and rearranged. At two round events, if one of the rounds is abandoned the competition shall be determined over the 18 holes that are played. At team pairs stableford regional and national finals, if weather conditions prevent completion of play, 8.3 provided nine holes have been completed by all players, team aggregate scores will be computed on the basis of nine holes (with countback rules applying to that nine as necessary). 9. Resolution of Ties 9.1 Unless otherwise specified in the rules of a competition, tied scores will be determined by way of countback over the last 9, 6, 3, or 1 as necessary. 9.2 In handicap stroke-play (medal) – the fractional system will be used. (ie. Gross back 9 less half of the playing handicap (unrounded) to calculate the net back 9. Then as necessary exactly one-third of handicap for the back 6, one-sixth for the back 3 and one-eighteenth for the back 1}. 9.3 In handicap stableford – the number of net points scored with shots taken as per the stroke index table. 9.4 Where this does not attract a winner joint winners or places will be announced. 9.5 In the knockout rounds of team events, countback shall be based on the aggregate of all cards for a team in line with the above. However, where this does not attract a winner, the tie shall be replayed and for single venue events home advantage shall switch to the other Club. 10. Closure of Competitions 10.1 The result of a match is deemed to have been officially announced once it has been verified by an NAPGC official, recorded on an open results sheet and that sheet has been publicly displayed. 10.2 A stroke play competition is deemed to be closed at the commencement of a presentation ceremony. (This does not preclude corrections for administrative errors being made). 10.3 In the case of team knock out matches, it is closed when the individual scores for each game have been agreed, signed off by a representative of each team and reported to the competition organiser and accepted. 11. Prizes and Presentations 11.1 Winners of trophies and/or prizes, both team and individual, who do not remain for a presentation which follows a competition will remain entitled to receive any trophy awarded but may forfeit their right to any prize that may be awarded. 11.2 The NAPGC Board will present any Player or Club that wins a competition on four consecutive occasions a trophy or memento marking the occasion, for them to retain (the Board will determine the choice of award). 11.3 The winning team or individual is responsible for the engraving and safe return of their trophy prior to the next playing of their event. 12. Miscellaneous Points of Clarification 12.1 Greensomes: Is a variation of Foursomes where both players play from the teeing area and one of the two tee shots is selected. The partner whose tee shot is not selected then plays the next stroke and each subsequent stroke is made in alternating order until the ball is holed. Otherwise, the Foursomes rules of golf apply. A side cannot commence play if both players are not present. 12.2 Provisional tee shots in greensomes: While both players are permitted to initially tee off in greensomes, where both tee shots may be lost or out of bounds, only one of the players is permitted to play a provisional tee shot which becomes the ball in play should both the original balls be lost or out of bounds. This is because the provisional ball would be the third shot of the hole, and two shots are only allowed for the first shot.

12.3 Mixed greensomes: From the tee, if the man elects to play the provisional it shall be from the women's tee and where the woman elects to play the shot it shall be from the men's tee (this similarly applies where a player has to return to the tee because a provisional has not been played).
 12.4 Trolley and buggy bans: If a buggy or trolley ban is in operation, games and matches should still be played as arranged unless the rules prevent the use of caddies. It is therefore recommended that players and clubs have contingency arrangements in place for those unable to carry his/her own clubs in such circumstances.

Section 2 - Knock Out Specific Rules

	1. Competition Draw
Initial KO	In knock out events each team will be placed in one of the national areas with a maximum of 16
Draw:	teams in any area. Every effort will be made to minimise excessive travelling.
Regional	Where required area winners will be drawn into national semi-finals, which shall be played on neutral
play offs:	courses, mid-point between each club. In the event of teams being unable to agree a neutral venue
	this will be determined by the Competition Organiser. The winners of these events shall meet in the
	national final which will be played on a neutral course usually in September/October.
Home	Where matches are to be played on a home or away basis, the first named team in each match shall
advantage:	have home advantage in the first round. In subsequent rounds the team which has played the most
	games away shall have home advantage, if this is equal then home advantage will remain with the
	first named team (this will be confirmed by the Competition Organiser before each round).
Loss of	In single venue events, where contact to offer dates has not been made by the contact by date, the
advantage:	away team can make contact offer dates and claim home advantage.
Match	Teams will normally be withdrawn from competitions if they fail to play a match by the date
Deadlines:	designated on the official draw sheet. The Competition Committee may reinstate teams if they
	believe there are extenuating circumstances.
Deadline	Extensions will only be considered in exceptional circumstances: such as inclement weather
extensions:	causing course closure on the last day of the round or a match having to be replayed.
	2. Arranging Matches
Team	For each event entered, Clubs shall be responsible for providing the names and contact details of
Captains:	those persons nominated as 'Team Captains'. In the knock-out stages of team series events, the
	team captain for each Club shall jointly be responsible for arranging matches. Any difficulty in
	arranging matches should be reported to the competition organiser as early as possible.
Arranging	Underpinning this the Captain of the first named team drawn to play another, or the home team in
matches:	single venue events, shall offer the opposing team three dates, weekend or bank holiday, on which to
	play the match. Of these dates, at least one shall be a Saturday and one a Sunday. The opposing
	team must then respond to the dates offered within five days. To facilitate tee booking, at least seven
	days match notice should be given.
Splitting	Whilst it is expected that the home and away legs of matches will be arranged to be played on the
play dates:	same day at both venues, matches may be played on different days and tee times may vary at each
	venue.
Days for	Unless otherwise specified (or agreed), matches should be arranged and played on Weekends and
matches	Bank Holidays.
NAPGC date	Unless otherwise agreed between the two clubs, no matches in the team series competitions may be
clash:	played on days when there are NAPGC regional or national finals being played.
Green fees:	For knockout matches and matches involving more than one team, played at a single venue, each
	club shall be responsible for its own green fees. Nb. Under the rules of Amateur Status, in team
	matches a player may be reimbursed costs for green fees, travel, accommodation and subsistence.
Finalising	Team captains are responsible for finalising and agreeing match details, including tee times and food
matches:	arrangements. For matches played on a home and away basis, the home club will be responsible for
	paying the green fees of the away team.
Slope	Once matches have been agreed the home team captain is responsible for informing the away team
details:	of the slope index relevant to the tee from which matches are to be played.
	3. Playing Matches

Initial KO	Team captains will be responsible for confirming the handicap index of their players. These shall be	
Draw:	as recorded on score cards and as shown and signed for on the team result sheet (printed	
	certificates will not be required).	
Handicap	Handicap index should be done through the WHS portal, England Golf app or by observation of a

Format:	Men's team aggregate greensomes event with twelve players playing as six pairs, in club v club knock out followed by a national final. Teams will initially compete on a regional basis, with three
	pairs at home and three away. Clubs may enter as many teams as they wish.
Timeline:	Competition entries are accepted through January and February with the knock-out draws issued before the end of March. Knock out rounds arranged between clubs take place from April until August and the national final in early September.
Scoring:	A team's score shall be the aggregate of the six pairs stableford points over 18 holes. The team with the highest aggregate points total shall progress to the next round. Area winners will be invited to the national final where all pairs will compete at a single venue.
Handicaps:	There is a maximum handicap index limit of 18.0 (players with higher handicaps may play but handicap indexes will be capped).
Allowance:	Playing handicaps for each pair shall be calculated as; lower course handicap x 0.6, plus the higher course handicap x 0.4. After adding the unrounded figures, the aggregate figure is rounded to provide the playing handicap.
Fees and costs:	The team entry fee shall be £30. Teams qualifying for the national final may additionally be asked to contribute up to £10 per player (£120) towards the heavily subsidised green fee.

Format:	Men's team aggregate better ball event with eight players playing as four pairs, in club v club	
	knock out followed by a national final. Teams will initially compete on a regional basis, with two	
	pairs at home and two away. Clubs may enter as many teams as they wish.	
Timeline:	Competition entries are accepted through January and February with the knock-out draws issued	
	before the end of March. Knock out rounds arranged between clubs take place from April until	
	August and the national final in early September.	
Scoring:	A team's score shall be the aggregate of the four pairs stableford points over 18 holes. The team	
	with the highest aggregate points total shall progress to the next round. Area winners will be	
	invited to the national final where all pairs will compete at a single venue.	
Handicaps:	There is a maximum handicap index limit of 28.0 (players with higher handicaps may play but	
	handicap indexes will be capped) and a minimum limit of 16.0. At least four of the eight players	
	must have a handicap index of at least 19.0.	
	Players may be paired together in any combination.	
	Teams should be selected to maintain this balance as far as is possible. However, if a player's	
	handicap is reduced after they have legitimately played off a higher handicap index in a previous

	teams as they wish.
Timeline:	Competition entries are accepted through January and February with the knock-out draws issued before the end of March. Knock out rounds arranged between clubs take place from April until August and the national final in early September.
Scoring:	There shall be three games within a match with play over 18 holes, or less if a side is more holes ahead than holes remain. A point will be awarded to the winners of each game and half a point for a tie. If a match is tied at one and a half points each, the first tied match (based on tee off order) shall play a sudden death playoff from the first tee. The team winning the most games (or play off) in a match shall progress to the next round.
	Area winners will be drawn into national semi-finals, which shall be played on a neutral course. The last two teams will compete at the national final.
Handicaps:	There is a maximum handicap index limit of 20.0 (players with higher handicaps may play but handicap indexes will be capped). Individual playing handicaps will be rounded course handicaps.
Allowance:	Having established course handicaps, the lowest player in each game will play off zero, with all other players receiving 90% of the difference in course handicaps from this player. All strokes to be taken as per the stroke index table.
Fees and	The team entry fee shall be £30. Teams qualifying for the national final may additionally be asked

Timeline:	Competition entries are accepted through January and February with the knock-out draws issued
	before the end of March. Knock out rounds arranged between clubs take place from April until
